



Twilight Bike Adventures Format and Rules



Both individual and team scoring systems have changed for Twilight Bike Adventures this year. The entire series will be based on points earned each week during both the bike races and the challenges. Points from races and challenges are cumulative and will count towards individual weekly winners and series champions.

- Competitors must declare which division they wish to compete in when they register. Divisions are: Under 13, Masters Women (50+), Masters Men (50+), Beginner Women, Beginner Men, Sport Women, Sport Men, Expert Women, Expert Men
- Under 13, Masters, Beginner, and Sport divisions will race 1 lap each week on the course. Expert (Women and Men) must race 2 laps each week.
- Competitors not through the finish line by 8pm will be pulled from the course and will receive a DNF (0 points) for the night
- Points are awarded each week for racing based on the following format:

- Competitors may move up to the next higher difficulty division if they wish. In order to move up a division, the competitor must fill out a division change form at the Activity Center BEFORE they race that day. Competitors may not move down a division once they have competed at the higher level division.
- Competitors will earn a one-time bonus when they move up from one division to the next. Bonus points are awarded in the following fashion:

Under 13 to Beginner	10
Masters to Sport	10
Beginner to Sport	10
Sport to Expert	20

- The amount of points earned by competitors at the Challenge Stations will vary each week based on the difficulty of the challenge, and on how well the competitor completes the challenge. The formula for awarding points will be posted at the Challenge Station, and points earned by each individual competitor will be added to their race points for their final point total.
- Weekly medals will be given out for 1st through 3rd place in each division, based on final point totals for that week only. A series award will be given out to 1st place ONLY in each division, based on the cumulative point total for the entire series.

TEAM SCORING

- Teams must consist of four competitors. No substituting is allowed once the series begins.
- Team members can be registered in any division. They will earn points based on which division they are competing in.
- Team score each week is the sum of each member's final point total for that week.
- Team points are cumulative and the team with the most points at the end of the series will be declared the winner.
