



2009-2010 DAY GROUP PRE-ARRIVAL PACKET

Dear Group Leader,

On behalf of the entire Schweitzer team, I'd like to thank you for your group skiing or snowboarding reservation. We've assembled information in this packet designed to streamline the pre-arrival and day-of-arrival at Schweitzer. If you follow these few steps, we're confident that your trip will run more smoothly.

Assembling Required Information from Your Group Attendees

As a group leader, we require you to collect the following information prior to check-in:

- 1) Total number of group participants (minimum of 20 total). You will receive one complimentary lift ticket per 20 paid lift tickets. There are no complimentary lessons or rental equipment packages available.
- 2) Total number within the group renting equipment – being careful to specify skis or snowboards.
- 3) Total number within the group taking lessons and type of lessons.
- 4) Lesson and/or rental release forms – attached to this document, must be completed for each participant participating in lessons or rentals. Please note that these forms must be signed by the participant or a legal guardian for minors – if you are bringing youth, please plan enough time to get signatures from legal guardians! If participants are not renting equipment or taking a lesson, no release form is required.
- 5) Collect necessary funds from each participant, being careful to include applicable taxes. For a complete list of prices, see the attached day group reservation form for reference – you will be required to pay for all products in one transaction with cash, credit card or organization check. Personal checks will not be accepted.

24 Hours Prior to Arrival (or earlier)

Please contact the Schweitzer Mountain Resort Group Sales Office at 208-263-9555 x. 2820 to confirm the total number of participants. We also appreciate knowing whether you will be arriving by cars, vans or busses. These numbers will help us in preparation for your arrival. In the event that your numbers change, we will make last minute adjustments upon arrival.

Day of Arrival

Upon parking, please proceed to The Cirque, Schweitzer's Group Welcome Center, located in the White Pine Lodge in the Schweitzer village. We ask that the group participants wait outside the office while the Group Leader completes the sales transaction for lift tickets, lessons and rentals. Please provide our service team with a cell phone number that can be used to reach the group leader in the event of an emergency. Upon receiving the necessary tickets and vouchers and paying in one transaction, the group leader will be responsible for distributing the tickets/vouchers to each group participant. Plan a meeting time and location for the end of the day and convey this to your group, allowing enough time for equipment rental returns. For those participants not renting or taking lessons, they are free to enjoy the mountain. Lesson participants or renters will proceed with a lift ticket, lesson and/or rental voucher and completed release forms (see attached) to the Ski & Ride Center, located in the Mill Building adjacent to the Basin Express lift and across from the Lakeview Lodge. (Whenever possible, a member of the sales team will accompany your group to this location.) Here, participants requiring rentals will be outfitted with the appropriate gear and lesson times will be scheduled.

A Few Tips

While lift tickets and rentals are available a-la-carte, a group lesson package offers significant savings. For a modest price difference, your group members can obtain significantly more value by including a group lesson. Also, please note that junior lift tickets are ages 7-17 whereas youth rentals are ages 7-12. (Youth rental equipment is defined by age, weight and height of participant. As a general rule, skiers under 13 or under 110 lbs and snowboarders 5 feet tall or less are considered youth rentals.) Finally, a variety of additional options are available for groups – from catered meals to private meeting space to snowtubing sessions. Please contact our sales team for more information on any of these great options.

LIABILITY RELEASE

PLEASE READ THE FOLLOWING RELEASE CAREFULLY BEFORE SIGNING

- I accept for use "as is" the equipment listed on this form and accept full responsibility for its care while it is in my possession. I will be responsible for the replacement at full retail value of any equipment rented under this agreement unless the equipment is returned to Schweitzer Mt. Rental Shop by the date agreed to above. Failure to promptly return leased property by the closing time on the date due may result in criminal prosecution and full retail charge. To avoid any additional charges the equipment will be returned in clean condition. I agree to check the equipment before each use and will not use the equipment if any parts are worn, missing or damaged. I am also financially responsible for any loss or damage to the equipment, other than reasonable wear and tear, which results from use of the equipment. I accept and clearly understand that there are inherent and other risks involved in the sports of skiing, snowboarding and snowshoeing, for which this equipment is to be used; that injuries are a common and ordinary occurrence of this sport, and I freely assume those risks.
- I and/or the user also understands that all types of mountain recreation are hazardous sports and accepts and assumes the inherent risks of the mountain recreation including but not limited to: changing weather conditions; bare spots; variations in snow, ice and terrain along with bumps, moguls, stumps, forest growth and debris and rocks; loose gravel and dirt, uneven terrain; grooming and other types of equipment on slopes; lift towers and other structures and their components; collisions with other and the recreational user's failure to participate within their own individual ability. In using equipment and recreating at the area, such dangers are recognized and accepted whether they marked or unmarked. The user realizes that falls and collisions and other accidents do occur and that serious injury or death may result and, therefore, assumes the burden of being in control at all times.
- I UNDERSTAND THAT THE SKI-BOOT-BINDING SYSTEM WHICH I HAVE RENTED WILL NOT RELEASE OR RETAIN AT ALL TIMES OR UNDER ALL CIRCUMSTANCES, NOR IS IT POSSIBLE TO PREDICT EVERY SITUATION IN WHICH IT WILL RELEASE OR RETAIN. I UNDERSTAND IN THE CASE OF SNOWBOARD, SNOWSHOE, AND TELEMAR SKIING EQUIPMENT, THE BINDINGS WILL NOT RELEASE. IN THE CASE OF A HELMET RENTAL, I UNDERSTAND THAT NO HELMET CAN PROTECT THE WEARER AGAINST ALL FORESEEABLE IMPACTS AND INJURIES TO THE HEAD AND WILL NOT PROTECT AGAINST NECK, CERVICAL, SPINE OR ANY OTHER BODILY INJURIES. I understand and agree that the binding systems, helmets and accessories are therefore no guarantee for my safety.
- I agree to RELEASE, HOLD HARMLESS, AND INDEMNIFY SCHWEITZER MOUNTAIN LLC, SCHWEITZER MOUNTAIN FACILITIES LLC, SCHWEITZER MOUNTAIN SKI OPERATIONS LLC, SCHWEITZER MOUNTAIN REAL ESTATE LLC, ("SCHWEITZER"), AND ITS OWNERS, AFFILIATES, AGENTS AND EMPLOYEES, THE EQUIPMENT MANUFACTURERS, DISTRIBUTORS, AND THEIR OWNERS, AGENTS, AND EMPLOYEES FROM ANY AND ALL LIABILITY FOR DAMAGE, DEATH, AND INJURY TO MYSELF OR TO MY PERSON OR PROPERTY RESULTING FROM NEGLIGENCE, THE SELECTION, ADJUSTMENT, AND USE OF THIS EQUIPMENT AND FACILITIES, ACCEPTING MYSELF THE FULL RESPONSIBILITY FOR ANY AND ALL SUCH DAMAGE, INJURY OR DEATH OF ANY KIND WHICH MAY RESULT.
- I have made no misrepresentations to Schweitzer in regard to my height, weight, age, or skier type. I agree that if any portion of this agreement is held to be invalid, the remaining terms shall continue to be in full force and effect. This agreement shall be binding upon my heirs, next of kin, executors, administrators, assigns, and representatives.
- If I am signing on behalf of a minor, I accept full responsibility for all medical expenses incurred as a result of the minor's use of the rental ski/snowboard/snowshoe equipment, facilities, helmet and/or accessories listed on this form. I agree to RELEASE, HOLD HARMLESS, SCHWEITZER, and its AGENTS AND EMPLOYEES, THE EQUIPMENT MANUFACTURERS, DISTRIBUTORS, AND THEIR OWNERS, AGENTS, AND EMPLOYEES FOR ANY CLAIMS BROUGHT ON BY THE MINOR.

I understand my child may ride the lift alone, with another child or with an adult other than his coach. I also agree to HOLD HARMLESS AND INDEMNIFY Schweitzer Snowsports School and Schweitzer for any claims brought by or on behalf of the minor.

In case of an emergency if I cannot be reached, Schweitzer has my permission to obtain any medical and/or First Aid treatment necessary for my child, and I agree to be financially responsible for any medical services deemed necessary.

This release is intended to be a comprehensive Release of Liability the fullest extent allowed by law.

I hereby grant Schweitzer Mountain Resort, their representatives or assigns (including any agency, client, partner or publication) irrevocable permission to publish photographs of me.

These images may be published in any manner, including websites, newsletters, advertising, periodicals and publications of any sort. Furthermore, I will hold harmless Schweitzer Mountain Resort, their representatives and assigns from any liability, by virtue of blurring, distortion or alteration that may occur in producing the finished product, unless it can be proven that such blurring, distortion or alteration was done with malicious intent to me.

Skier Levels (ages 13+)

- Level 1** Your first time on skis.
Lesson Focus: Stopping, basic turns, easiest terrain.
- Level 2** You can sort of turn and stop. Green circle runs at an easy pace
Lesson Focus: Be able to link turns comfortably on easy Green runs.
- Level 3** Can turn and stop comfortably on easy Green circle runs.
Lesson Focus: Be able to link turns consistently and venture onto easy Blue square runs. This class will probably leave Musical Chairs for the first time.
- Level 4-5** Intermediate type skier. Sometimes uses a wedge to start turns.
Lesson Focus: To feel more in control on blue runs.
- Level 6-7** Skis mostly parallel except on harder runs. Not very comfortable on black diamond runs or in variable conditions (powder, crud, moguls).
Lesson Focus: Better speed control on steeper Blue and easy Black runs. Introduction to different snow conditions.
- Level 8-9** Advanced and expert skiers. Can make it down almost anything. Has been skiing for a long time but knows there's always room for improvement.
Lesson Focus: To be able to rip on anything, anytime.

Snowboard Levels (Ages 13+)

- Level 1** Your first time on a snowboard.
Lesson Focus: Basic control, riding lifts, having fun.
- Level 2** You can slide – slip, traverse, and perhaps turn in one direction.
Lesson Focus: Learn basic turns in both directions.
- Level 3** You can turn toe and heelside on easy Green terrain.
Lesson Focus: Smoothly link turns and ride easy Blue runs.
- Level 4** You can link turns on all but steepest groomed runs.
Lesson Focus: Performance Riding: carving, venturing off the groomed.
- Level 5** Advanced and Expert riders who are comfortable most places.
Lesson Focus: Off groomed, steeper Black Diamond runs, variable tactics and techniques.

Mountain Riders Ski Teams (Ages 7-12)

- Red Team** First time skiers and skiers learning to stop.
Lesson Focus: We will be getting acquainted with the equipment, learning to glide and stop, and introducing turning.
- Green Team** Skiers who can stop, and are learning to turn.
Lesson Focus: We will practice turning and speed control, riding the chairlift, and skiing beginner terrain.
- Blue Team** Skiers who can stop and turn on all green terrain.
Lesson Focus: We will work on matching our skis sooner in the turn so that we are skiing parallel more of the time. We will explore most of the mountain on intermediate runs.
- Black Team** Skiers who ski parallel on all blue terrain.
Lesson Focus: We will work on refining our movements on a variety of advanced terrain, trying to carve more on the groomed and maintaining balance and control on the ungroomed.

Mountain Riders Snowboard Teams (Ages 7-12)

- Red Team** First time riders and riders learning to side-slip.
Lesson Focus: We will be getting acquainted with the equipment, learning to control speed and stop, introducing turning.
- Green Team** Riders who can side-slip, and are learning to turn.
Lesson Focus: We will practice turning and speed control, using the chairlift, and riding beginner terrain.
- Blue Team** Riders who can turn from toe-side to heel-side on all green terrain.
Lesson Focus: We will work on exploring more of the mountain, making different types of turns, and learning basic freestyle maneuvers.
- Black Team** Riders who are confident turning on all blue terrain.
Lesson Focus: We will work on refining our movements on a variety of advanced terrains and riding in the terrain park.
